Trained medical staff are available for medical needs and provide education to children. The camp is located 160 miles north of the the Twin Cities on a beautiful 30 acre peninsula of woodlands at Camp Knutson in Crosslake, MN.

Camp Odayin Family Camp - provides a camp experience to families offering support, education and networking for children with heart disease and their families. Family camps take place each fall and are located in Amery WI and near Milwaukee, WI.
