In an atmosphere designed to enhance self-concept, gain independence and develop life skills - children with heart disease have the opportunity to come alive emotionally and physically. Trained medical staff are available for medical needs and provide education to children. The camps are located at Camp Knutson in Crosslake, MN and Camp Lutherdale in Elkhorn, WI.

Camp Odayin Family Camp - provides a camp experience to families offering support, education and networking for children with heart disease and their families. Family camps take place each fall and are located in Amery WI and near Milwaukee, WI.
